3. Discuss and possible action regarding the condition of the rail car "Alamo" and progress of its restoration as outlined under the Performance Agreement between the Elmendorf Economic Development Corporation for incentives to the San Antonio Railroad Heritage Museum, Inc. to enhance the museum facilities in Elmendorf, Texas.

City Attorney Mike Guevara explained letters were drafted for both the Mayor Michael Gonzales and EEDC President Manuel Decena advising the museum of council's action at the March council meeting. The letter demanded three concerns to be addressed within a specific timeframe. Those concerns being the painting of the exterior rail car, replacing the back fence of the property they removed to move the Alamo in, provide evidence that they are and have been open to the public. The museum was invited to attend the meeting but they did not send a representative.

City Administrator Cody Dailey states the museum has made an effort to replace the fence but it is not completed. The top priority of the city was for the exterior to be painted but after four (4) years, it has not been completed. An email was received from their President Gary Rodriguez stating the museum closed in January and February to give the volunteers a break. Mayor Pro-Tem Hicks believes they are usually at the building on the weekends but they do not open to the public. Councilwoman Ortiz is very disappointed and angry that after four years, no progress has been made. So many promises were made when they needed the funds to bring in the rail car.
