Councilmember Ortiz points out that the railroad car was in the museum possession since March of 2018 and is very disappointed in the actions of the museum. Councilmember Ortiz further states that pictures of the condition of the museum displayed no areas to walk and seemed to be using the building as storage.

City Administrator Cody Dailey advises City Council they must determine if they feel the Museum is in breach of contract.
