City Attorney Mike Guevara explains to City Council that they have two options: they can adopt a resolution consenting to the use of Aqua's pre-existing tariff and rate structure; or adopt an ordinance to give up all decision-making authority to the Public Utilities Commission (PUC). Issá McDaniel, MPA, the business development manager of Aqua Texas states that their rates are to recoup the cost for the management of the sewer system and there is a complex process conducted by the PUC to ensure of that. Approving this resolution would consent to rates already in existence that Aqua charges their customers in the SW region which were approved by the PUC. This option would also prevent further delays in service to the homes and the city will have a say in any future changes to the rates.
