IV. General Business - Individual Consideration

3. Discuss and possible action regarding a potential future Planned Development District at an area located generally at the intersection of US Hwy 181 and Loop 1604.

Daniel Ortiz, of Ortiz McKnight, PLLC, presents the Planned Development District (PDD) to the City Council. He is presenting the final plan after many revisions submitted to city staff for the past year and a half. This plan has removed all C-3 and M-1 districts. There are six individual uses with conditions for acreage, size, and density limits. Also, outside storage is prohibited. Mr. Ortiz commends city staff as they have been good to work with.

Councilmember Hicks motions to approve the Planned Development District at an area located generally at the intersection of US Hwy 181 and Loop 1604. Councilmember Riojas seconds.

Councilmember Riojas trusts Mr. Dailey and the staff's recommendation. Councilmember Hicks thinks most of his concerns have been addressed. Councilmember Dziuk also states he trusts the staff's recommendation. Councilmember Decena asks for City Attorney Mike Guevara's statement. Mike Guevara states there is nothing legally to be concerned with and it is up to City Council if they wish to approve this compromise with the Elmendorf Land Partnership. Councilmember Ortiz asks for Mr. Dailey's opinion. City Administrator Cody Dailey says he is a skeptical person but a lot of concerns have been alleviated.

4. Discuss and possible action regarding a future project of the Elmendorf Water System to add a Reverse Osmosis Treatment facility to our system. Our City Engineer, Garry Montgomery, will be providing a presentation.

Mr. Montgomery gives a PowerPoint presentation on the introduction to Reverse Osmosis. An explanation of how it works and the projected costs of construction, operation and maintenance of the facility. He also compared those costs against the cost of continuing our blending program with SAWS.

City Administrator Cody Dailey says it makes the most financial sense to continue blending with SAWS water. Mr. Dailey is not recommending the city pursue the reverse osmosis treatment facility at this time but the City Council should consider if breaking its ties from SAWS is worth another ten-million-dollar project.
