City Administrator Cody Dailey advises City Council that VP Racing Fuels is located outside of the city limits but they are inside the city's Certificate of Convenience and Necessity (CCN), which requires them to receive water service from the City of Elmendorf. At some point in history, long before current staff was hired, a number of homes and businesses were allowed to receive water service from SAWS and/or East Central SUD.

VP Racing Fuels currently receives its water from SAWS and is undergoing expansion. They are in need of a new fire suppression system water line. In order to receive this, SAWS requires the city's permission to install the line on their property. Mr. Dailey has no issue if City Council wishes to grant this request.
