Citizen comments – Deborah Ramirez received a code violation letter for her property because she has a storage container in a residential district. This isn't the only violation letter she has received before and feels she is being targeted. Mayor Gonzales assures her that her property is not the only one that has received letters and the code compliance position is actually something he started because he wanted the city to clean up. There is a report he receives every month of all the addresses with violations. Ms.

Ramirez would like to request that information. City Council wishes to bring this subject back for discussion at next month's meeting.

IV. General Business - Individual Consideration

10. Discuss and possible action regarding an additional 1-year extension for Jesse Palomo to come into compliance with Chapter 6, Article 13 of the Elmendorf Code of Ordinances in reference to RV Park regulations.

Jesse Palomo is present to request an extension to bring his RV Park into compliance. Mayor Gonzales asks what more needs to be done in order to be up to code. City Secretary Roxanne De Leon advises City Council that Code Compliance Clerk Janie Cantu is scheduled to conduct an inspection on December 26th. She will be able to provide the full scale of what needs to be completed at that time. Mayor Gonzales suggests tabling this item until the inspection is completed.

Councilmember Decena motions to table this item until next month. Councilmember Maldonado seconds and a vote is called.

Mr. Palomo doesn't understand why he needs to go through an inspection. City Administrator Cody Dailey states the issue with tabling it would be a problem because the permit needs to be issued. An extension would have to be allowed until the next meeting. Any RV parks that were pre-existing the ordinance should be granted that extension to keep it fair.

Motion dies.

City Engineer Garry Montgomery took a look at the area after a citizen requested the addition of streetlights on Elmendorf-La Vernia. It was found that one of the poles had a streetlight already but needed repair. A work order to CPS has been submitted. Our city code requires new streetlights be placed at least every 500 feet. Mr. Montgomery provides his recommendation on the addition of three streetlights on certain pole numbers.
