Councilmember Maldonado asks if the city is required to accept this holiday or give employees the day off. Mayor Gonzales states it was federally mandated. Councilmember Maldonado is concerned if the city can afford to give employees the day off and how it would affect the community to pay employees for a day off with their tax money. Councilmember Maldonado doesn't recommend approval. Councilmember Ortiz would prefer to go along with the federally recognized holidays.

Councilmember Maldonado asks how many holidays the city currently recognizes. City Administrator Cody Dailey states there are twelve (12) full days and two (2) half days. Councilmember Riojas asks when was the last time a new federal holiday was added. Councilmember Hicks states the last time was twenty (20) years ago.

The motion to accept the addition of Juneteenth as a holiday is passed on a majority vote with four (4) councilmembers in favor and (1) abstained. Councilmember Maldonado abstains.

Councilmember Maldonado requests the City Council to reopen this item for discussion.

Councilmember Decena states the city would still be federally mandated to pay the employees for the holiday whether they had the day off or not. Councilmember Maldonado would like to hear from the public their thoughts on the holiday.

Councilmember Ortiz asks citizen Minnie Slaughter how she feels about Juneteenth. Ms. Slaughter is in support of the holiday and considers all that the employees do for the government. If a member of council worked for the government, they would like to accept this holiday. Citizen Laura Wright-Wallace is in support of the holiday. All other holidays that are recognized are appreciated and are a benefit to an employee. If the city wanted to pick and choose just a handful of holidays, employees may feel unappreciated and look elsewhere. Employees should be retained. Emilia Clarke is in support of the holiday as people work too much. Chaplain Stirnemann believes we should follow the federal holidays particularly in the current environment. Ms. Wright-Wallace also points out that if one more day is going to break the city, there is a bigger problem that the city needs to worry about.

City Attorney Mike Guevara advises City Council they do not have to take action if they want to stick to original motion. No further action was taken.
