10. Discuss and possible action regarding brush pile burning complaints and possible alternatives.

City Administrator Cody Dailey states a complaint was received a few weeks ago from a citizen who lives near the park regarding our burning of brush at the park. This citizen states that she has COPD and the smoke from the fire is problematic to her health. The brush pile collection has grown over the yeas with three local tree services that live within our city limits to take advantage of the brush pile here and pay the fees in order to do so. Unfortunately, it has created much larger brush piles than we used to have in years past, with large trunks that will smolder for days if not weeks.

Tiger Sanitation has offered to do a third curbside pickup of brush during the year. This would be limited to only two cubic yards and would add an additional \$6,000.00 per year to the contract. Or they can do an on-call brush pickup to remove brush from the city park at \$450.00 per load (30-yard container). We would probably need it emptied every 2 to 3 weeks. Using a worst-case scenario of every 2 weeks would estimate to \$11,700.00 per year. We currently charge for brush drop off but the fees we earn would come nowhere near the amounts we would have to pay for Tiger to haul it off.

City Council has to consider the following options: Do nothing and continue burning at the park, raise rates for commercial drop off, choose one of the options for Tiger or a combination of the options from Tiger.
