3. Discuss and possible action regarding Ordinance 3-11-2021-1, creating procedure for providing adjustment for excessive water service bill following the February 2021 Winter Storm Uri; and providing an effective date.

City Administrator Cody Dailey states this item ratifies the mayor's decision to extend the relief provided by SAWS to its water customers. If a customer's January bill was lower than the February bill, the city will adjust the bill for the lower amount. Mr. Dailey explains the winter storm caused many plumbing pipe breaks and many customers had leaks. The city averages 5 million gallons of water usage but the month of February came in at 8 million gallons. The total adjustment for all customers is approximately \$32,000.00.
