4. Receive presentation of and discuss Fiscal year 201-2019 audit from Wayne Beyer CPA.

5. Discuss and possible action regarding the waiver of building permit fees for the ESD #10 fire station.

A request from Fire Chief Bobby Hogan to waive building permit fees for the ESD #10 fire station was received by email. The total dollar amount the city would charge for the permit fees would be \$15,524.44. From this amount, the city would pay the plan reviewers and inspectors at Bureau Veritas \$6,800.00 and the city engineer \$5,670.00 to review the civil plans. City Administrator Cody Dailey can see a potential waiver for the remaining fees on staff time at \$3,054.44. Chief Hogan states that there are funds available to pay the permit fees but they were not budgeted into the cost of construction and had assumed the permit fees would be waived.

6. Discuss and possible action regarding water meter service at the ESD #10 fire station for fire truck fill-ups.

City Administrator Cody Dailey states that the fire department currently fills their tankers at fire hydrants. They are not charged for this water and it is not metered. There is not an issue for the fire department receiving free water to fill their trucks but Mr. Dailey encourages a meter be installed at their fire station to get an accurate number for the city's water loss reports. The meter provided for filling the fire truck is not used for any other purpose.
