7. Discuss and possible action regarding a rezone request from Jaime A. & Elida L. Garcia for a map amendment to Ordinance 12-12-2013-1, the City of Elmendorf's Zoning Ordinance; property location 706 5th Avenue, Elmendorf, Texas 78112 (Property ID# 173778); from a Residential District (R-1) to a Commercial District (C-3).

Elida L. Garcia moved to Elmendorf in 2000 and her family is in the hair industry. Ms. Garcia would like to operate her salon in the home she owns next door to her residence. Councilmember Decena is familiar with her business and his wife is waiting for the business to open up. City Attorney Mike Guevara advises council that C-1 would be a preferable zone than a C-3. That zone would allow her to operate her business but a C-3 is for more heavy commercial. Mr. Guevara reminds council that if they approve the rezone request, anything that classifies for C-1 can operate there and to be aware of spot zoning where it would be illegal.

The number of COVID-19 cases has gone up to 29. Due to lack of testing, it is predicted that there's at least a thousand people infected. The community spread has caused the infected number to double every one to two days. Mr. Dailey recommends closure of the lobby and slowing down traffic tickets. In the case where a full-time officer falls ill, a reserve officer can take their place at the pay rate of \$15.00 an hour until the officer returns.
